

## **Boat Placement for RICC Members Boats on RICC Lakes**

1. Registration of boats for Lakeside Racks must be assigned by the Caretaker
2. Rack slots for boats will be issued on a FIRST COME basis.
3. Rack slots are effective from 1 APRIL – 1 DECEMBER.
4. You MUST renew your slot assignment with your “Current” membership card each year.
5. All boats are stored at owner’s risk; the RICC is NOT RESPONSIBLE for any damage, thefts of boats, or any stolen items from boats.
6. All boats must have the owners name (2 inch or larger printed) and current state registration stickers displayed on the boat.
7. Each slot will have an assigned number and the caretaker will register your boat to a slot and rack number.
8. The club will not provide any assistance in the movement of boats to or from lakeside racks.
9. Boats may be chained and secured to the racks. Racks will not be altered in any manner to secure your boat.
10. Boat owners must monitor rising waters due to flooding. You must remove your boat from the rack if flooding reaches the racks. Your boat will be removed from the rack and placed in lockup if flood waters threaten the integrity of the racks. It is your responsibility to protect your boat and RICC boat racks from flood/rising waters.
11. Any boat found in violation, such as: boats without the proper state registration and name on the boat, boat being placed on the wrong rack, boats placed on the racks without being registered with the RICC Caretaker or any boat placed on the shoreline. If a boat is found in violation the boat will immediately be placed in a lockup status and fined \$50.00. The member of the boat in violation must appear in front of the RICC Board of Directors and pay their fine before their boat will be released from lockup.
